In my role as Founding Program Director I strategically led, designed, developed, and implemented the processes required for a successful accreditation of the program. We used Kaufman's mega planning framework as a guide to align the sponsoring institutions' mission and vision with that of the clinical hospital system, Sarasota community, and society's need for primary care physicians. Our hospital and program leadership engaged key community stakeholders from the city's most underserved area to ensure that our residency program addressed the needs of the community when designing the Resident's Continuity Clinic. By engaging the community and like minded organizations, this practice provides multi-disciplinary services inclusive of free legal aid to patients on issues that impact health; partnerships with Good Samaritan Pharmacy, the food bank and farmer's market, and nutrition services. Lastly, the practice serves as a site for Newtown High School students to shadow professionals in all of the above mentioned disciplines. The end result was a Graduate Medical Education program plan that adds value to the community, aligns with the Accreditation Council for Graduate Medical Education's (ACGME) vision for reducing healthcare disparities, promoting diversity, equity and inclusion, and compliant with ACGME program requirements. The program was granted accreditation with commendations from ACGME.

I provide Sarasota Memorial Hospital with strategic guidance about the development of other graduate medical education programs. Emergency medicine received initial accreditation status in April of 2018 and Hospice and Palliative Care fellowship program.

Competency-Based Journaling:

I developed a series of qualitative and quantitative competency-based journaling activities. Residents self-assess and reflect upon their performance in patient care, medical knowledge, interpersonal and communication skills, practice-based learning, professionalism, and systems-based practice. Utilizing the results of these activities to design individual learning action plans provide both learner and educator with life-long skills for self-directed assessment and performance improvement. (received a commendation by ACGME)

GME Measurement and Performance Management System Model:

As part of our strategic initiative to systematically plan and manage our educational efforts and to make data driven decisions for performance improvement, we created a Graduate Medical Education Performance Measurement and Management System model. This work resulted from collaboration with the WSU College of Education and has led to the development of the Program Portfolio Performance Tool and the GME Leadership Model.

Program Portfolio Performance:

We developed and piloted a "Program Performance Portfolio" (P3) tool designed to facilitate graduate medical education leadership, oversight and management of resident and fellow education programs.

The Program Portfolio concept is an automated structure for planning and managing, competency-based learning activities, evaluations, curriculum, program reviews and reports, performance improvement initiatives, and other relevant program educational and evaluation activities. This tool was the foundation for

the DMC GME Score Card.

GME Leadership Model:

We developed a GME Leadership Model that identifies Program Director core competencies through the adaptation of Lominger's Leadership Model. We utilized this model to design and deploy performance improvement interventions ranging from professional development workshops to leadership coaching for Program Directors.

GME Leadership Academy:

Based on the findings from the GME Leadership Model, we designed and developed a longitudinal faculty development program for GME Leaders and Program Administrative Support Staff. The course was launched in February 2011.
